THE RONALD MCDONALD HOUSE SERVED 299 FAMILIES IN 2020, PROVIDING THEM WITH A "HOME-AWAY-FROM-HOME" FOR 3,277 NIGHTS. THE HOUSE ALSO SERVED FAMILIES BY PROVIDING HOTEL STAYS FOR 127 NIGHTS IN 2020. IN A TYPICAL YEAR, NEARLY 1,200 FAMILIES ARE SERVED, HOWEVER COVID-19 SAFETY PROTOCOLS LIMITED THE NUMBER OF FAMILIES SERVED IN 2020.

WHEN FAMILIES FACE A CHILD'S ILLNESS THEIR LIVES STOP INSTANTLY, AND PARENTS ENTER A WORLD OF FEAR AND WORRY. THE RONALD MCDONALD HOUSE ENABLES FAMILIES TO FOCUS ON THE HEALTH OF THEIR CHILD NOT WHERE THEY CAN AFFORD TO STAY, FOOD, OR HOW THEY CAN STAY TOGETHER AND NEAR THEIR CHILD.

THE RONALD MCDONALD CARE MOBILE PROVIDES FREE DENTAL CARE AND ORAL HEALTH EDUCATION TO UNDERSERVED CHILDREN IN CENTRAL ARKANSAS. A TOTAL OF 2,024 PROCEDURES WERE PROVIDED TO 230 CHILDREN IN 2020. AS A RESULT OF COVID-19 AND SOCIAL DISTANCING PROTOCOLS, THE CARE MOBILE WAS AT REDUCED CAPACITY - TREATING ONE CHILD AT A TIME. MANY OF THESE CHILDREN HAVE NEVER SEEN A DENTIST BEFORE AND THEIR PARENTS DO NOT HAVE INSURANCE TO BE ABLE TO PROVIDE MUCH NEEDED DENTAL CARE TO THEIR CHILDREN. THIS 40-FOOT, STATE-OF-THE-ART, FULLY EQUIPPED MOBILE DENTAL CLINIC, TRAVELS TO SELECT ELEMENTARY SCHOOLS AND SUMMER PROGRAMS IN PULASKI, SALINE, PERRY, FAULKNER, LONOKE AND GRANT COUNTIES.

THE RONALD MCDONALD FAMILY ROOM AT UAMS SERVED 99 FAMILIES DURING THE DAY AND 13 FAMILIES OVERNIGHT IN 2020, PROVIDING THEM WITH A "HOME-AWAY-FROM-HOME" FOR 138 NIGHTS WHILE THEIR CRITICALLY ILL BABY WAS RECEIVING INTENSIVE MEDICAL CARE IN THE NICU. FAMILIES ENJOYED A COMFORTABLE, WELCOMING PLACE TO REST AND REGROUP IN THE HOSPITAL, STEPS AWAY FROM THEIR BABY'S ROOM. THE FAMILY ROOM SERVED ITS FIRST FAMILIES ON FEBRUARY 2, 2020. DUE TO HOSPITAL SAFETY PROTOCOLS ENACTED BECAUSE OF COVID-19 THE FAMILY ROOM CLOSED ON MARCH 21 AND REOPENED ON SEPTEMBER 21 FOR DAY USE ONLY. ADDITIONALLY, DURING ITS CLOSURE, THE FAMILY ROOM WAS REPURPOSED FOR USE BY UAMS'S NICU MEDICAL TEAM SO THAT THEY COULD SAFELY DISTANCE WHILE AT THE HOSPITAL.

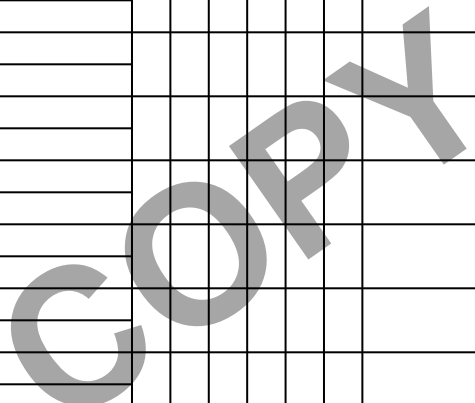

AND KIDS CLOSET, YOGA, RELAXATION CLASSES AND MORE) AS WELL AS THE
SUPPORT OF OTHER FAMILIES EXPERIENCING SIMILAR CIRCUMSTANCES.
